

As 2025 draws to a close, there are many ways to make a meaningful impact with your generosity — while also maximizing your tax benefits. Consider these giving options before December 31, 2025:

■ Mail a Check or Donate Stock

Donating stocks or other noncash investments can help you avoid capital gains taxes while still receiving a fair market value deduction.

☐ Send a Wire Transfer

Instruct your financial institution to wire funds to the Society of St. Vincent de Paul Galveston-Houston. □ Consider Bunching Gifts If you itemize deductions in some years but not others, combining donations into a single year ("bunching") may increase your overall tax savings. ☐ Use a Donor-Advised Fund Make a tax-deductible contribution now and recommend grants to your favorite nonprofits over time. ■ Make the Most of IRA Gifts If you're age 70½ or older, you can give up to \$105,000 directly from your IRA to a qualified charity—meeting your Required Minimum Distribution (RMD) while reducing taxable income. □ Think About Your Legacy Including the Society in your will, trust, or beneficiary designations ensures your impact continues for generations to come. □ Plan Ahead Gifts such as business interests or real estate may require additional time for valuations, legal review, and processing—so be sure to start early. South Central Regional Cycle Closes December 5

Grants up to \$5,000 are available! APPLY TODAY!

Grants are targeted to specific, current emergency assistance needs of the poor, above and beyond available resources. Preferred interest areas are: rental/housing assistance, utility assistance, food, clothing, transportation, baby/children needs, and medical. No systemic change projects.

Grant Award Requirements:

- A Conference must be aggregated, and the District Council must be instituted.
- If you have received a grant within the last 2 years, you are not eligible to apply.
- Grant funds are expected to be exhausted within 6 months.
- A Grant report is due within 6 months, outlining in detail how the funds were used.

Email confirmation from your Council President showing they reviewed and approved your application is acceptable in place of an actual signature.




Fall Is Here—Let Your Vincentian Pride Show

Take a moment to browse the store and find something that keeps you warm—and keeps the Vincentian spirit visible.




























Phase I: Getting Ahead Program

The Getting Ahead Program is now accepting <u>applications</u> for Cohort 10, beginning in January

We're looking for neighbors who have received assistance and are ready to take steps towards building a better future.

Potential participants should not currently be facing an immediate life crisis, such as an eviction.

Getting Ahead in a Just-Gettin'-By World is a 16-week series for motivated neighbors ready to change their lives by acquiring the tools and support necessary to "get ahead" in today's world.

Getting Ahead takes participants on a step-by-step journey to

discover resources and build the resiliency necessary to overcome life's obstacles. This program is executed in three phases to gradually help participants build the life they want.

Three reasons to report cybercrime:

1. Protects Sensitive Data

Nonprofits often handle donor information, financial records, and sometimes personal data of beneficiaries. Cyberattacks can lead to identity theft, fraud, or exposure of vulnerable populations. Reporting helps authorities track and mitigate these risks.


2. Maintains Donor Trust

Donors expect their contributions and personal details to be secure. If a breach occurs and isn't reported or addressed, it can damage the organization's reputation and reduce future funding.

3. Helps Law Enforcement Combat Cybercrime


Reporting incidents provides valuable intelligence to law enforcement and cybersecurity agencies. This helps them identify patterns, dismantle criminal networks, and prevent future attacks.
